### President's Message



It has been a busy and challenging year for the Nova Scotia School Boards Association (NSSBA). The challenges have spurred us on to achieve some great things. 2008-09 has been a year of strong partnerships and I have confidence that as we continue to focus our efforts and collaborate with like-minded partners, we will increase our effectiveness.

A downturn in the global economy had implications for all regions of Canada this year and Nova Scotia was no exception. Many education stakeholders were concerned that public education would suffer.

A group of education partners including school boards, administrators, teachers and parents has been working collaboratively on the issue of education funding. During the winter the group developed a joint action campaign that utilized print and radio ads, a website, Facebook and meetings with MLAs to drive home the message that an increase in public education funding was necessary to avoid drastic cuts. This campaign, entitled *Public Education: Our Best Investment!*, culminated in a rare joint

news conference on January 15<sup>th</sup>. A great deal of media interest accompanied the campaign and it was clear that whengroups representing different stakeholders deliver a consistent message across Nova Scotia, people take notice.

I am pleased to say that I believe our lobby efforts were very successful. We received a funding announcement in April that came close to our target: we asked for \$45-50 million and will be receiving \$44.8 million. The government's news release noted the strong lobby effort.

School Board Elections were held in October 2008. The elections provided an opportunity for the Halifax Regional School Board and the Strait Regional School Board to be re-constituted after disbandment, and they also enabled boards to highlight the valuable work they do. NSSBA provided leadership to a joint partners' committee to develop tools and strategies with which to raise awareness of school boards, increase the number of candidates running for office, and improve voter turnout. Joining NSSBA on the committee were representatives from school boards and the Department of Education, administrators, teachers and parents. This positive partnering experience reduced duplication of effort and improved communication between the partners and the public.

The fall elections brought some new faces to school boards across the province. NSSBA offered an Orientation Seminar in November. New and experienced board members gathered to network and to hear presentations on relevant, timely topics with a focus on school board governance.

The NSSBA has continued to collaborate with the Department of Education, the Nova Scotia Educational Leadership Consortium, the Nova Scotia Teachers Union and other partners to deliver training and informal sessions on a variety of issues affecting students.

NSSBA entered the 2008-09 year without the Halifax Regional School Board as a member. I am hopeful they will re-join the association this year, as Halifax's membership is incredibly important in shaping education in the province. With complete provincial membership, all of the 135,000 students in Nova Scotia could once again reap the benefits of having a united voice advocating on their behalf. A united voice is a strong voice.

The Canadian School Boards Association Congress 2009 is shaping up to be a great conference. We are looking forward to hosting this national event. Registration numbers from western and central Canada are high so let's ensure that representation from Atlantic Canada is strong too.

And lastly, I would like to recognize the commitment and dedication of the executive, the board of directors, executive director Ken Meech and the NSSBA staff for the support and guidance given to me as president. The contributions made by all of these groups ensure that the NSSBA continues to serve the needs of its members. I appreciate the opportunity to serve as president of such a valuable organization.

### Executive Director's Message



#### **Highlights**

The school board elections last October will be remembered for the reinstatement of democracy, with all eight elected school boards again in place. As an information item, the proposed changes by the province to enhance governance have yet to be proclaimed and there has been no update on implementation.

The joint memorandum of understanding (MOU) committee commenced meeting in 2008 with a number of productive sessions. However we are experiencing difficulty in having the meetings regularized with the minister's participation. The next meeting of the committee with the deputy minister and staff is scheduled for May 20. We must give this process high priority and assert our voice for the need to dialogue on the broader issues facing the system. We must be prepared to contribute in a constructive and reflective manner to identify improvements to enhance the student learning

process. We must also practice our belief in endorsing change based on empirical evidence.

The major activity in the past six months has been the successful joint action campaign which we delivered with our education partners. The president has covered this in adequate detail. The success of this campaign is evidenced by the funding announcement for 2009/2010.

The Lead & Achieve committee has met to update the educational plan which includes our priorities on the education front. It should be noted that the yearly adoption and update is critical, as this balances the association's key focus of funding and education program priorities needed to achieve our vision for EXCELLENCE IN PUBLIC EDUCATION. The composition of the committee was revised to include the executive and board chairs.

The board of directors has given approval to proceed with a strategic planning process to reflect on the role, mandate and purpose of the NSSBA. This exercise will also define our key focus for the next several years. We have retained an accomplished facilitator, Lawrence Ryan, to guide us through the process. We plan to conclude the exercise with a membership meeting in the fall to review the outcome prior to board endorsement of the plan. This represents your opportunity to ensure the association is aligned with the direction and focus of the membership.

As you know, the school capital process was reactivated this past year. The province has announced the list of projects which represents a significant commitment to the construction of new schools and major additions /alterations. The Department of Education deserves high marks for this initiative.

A major accomplishment this past year has been the Department of Education's approval to proceed with the implementation of the Student Information System (SIS). The SIS is a tool that provides teachers, system administrators and boards with the ability to track individual student progress and achievement. We acknowledge the leadership of the superintendents in partnership with the deputy minister that made this a reality.

#### **Observations**

Our major reason for existence is to work towards EXCELLENCE IN PUBLIC EDUCATION with the following

#### values:

- 1) We believe in accountability.
- 2) We believe all students are entitled to an education.
- 3) We believe the public education system must meet the diversity of needs.

I believe we have to stop and reflect on the path ahead to continue to move forward. The world is changing rapidly - the knowledge and skills necessary for the future are much different from those required in the past. Part of the challenge has been to build a system that meets the needs of individual students, or as they say, customization of the public education system. To improve on that model, research says that we need to implement a Professional Learning Community (PLC) model which empowers schools and teachers to identify, via mentorship, collaboration and professional development, the tools and resources necessary to address individual student needs. The implementation of the SIS should assist teachers with their task. We must give schools the latitude they need to develop the means to achieve this end. A key ingredient is having the process imbedded in the culture and practices of our system. There are many examples of this practice being championed by the leadership of teachers and school administration. However the challenge is to define a framework which enables this approach for all school sites. My belief is that the collective bargaining table is not the means to the solution, as the rigidity of that process and the outcomes work contrary to the necessity of flexibility in the process.

We need to advocate the process and work with key stakeholders to find a solution that respects all of the key participants in this effort. Teachers and school administrators should be given greater latitude in the design of these processes, thus assuming responsibility for their success or failure. To move forward, the NSSBA should play a role in fostering open and transparent collaboration among the partners.

To conclude, my purpose in sharing these thoughts is to make a call for stakeholders to work together in an inclusive and collaborative environment for the best interests of the student, with the collateral benefits of social and economic prosperity.

Our greatest strength comes from speaking with one voice in our advocacy role on behalf of all students in Nova Scotia. This is also a call for the Halifax Regional School Board to rejoin the association so the school boards of Nova Scotia can speak with a united voice. Given the economic challenges facing governments, a single message is a must.

It has been a rewarding year and I want to thank the board of directors for their continued support and wise counsel. I am fascinated by Ron Marks' energy and excitement to learn so that he can make a difference in enhancing student success.

Also I want to thank the NSSBA staff: Sharon, Karen, Marie, Meghan and our newest member Carmen for their efforts and their commitment.

My thanks also go to the boards, superintendents and school board staff for their trust, guidance, cooperation and most importantly, their friendship.

Our key initiative this past year has facilitated a closer and positive working relationship with our education partners who have demonstrated their commitment to public education.

Finally, I want to acknowledge the cooperation, trust and confidence that are a part of our relationship with the deputy minister and the Department of Education staff who have been helpful in providing information and guidance.

### **Communications Report**

#### **Major Initiatives 2008/2009**

#### 1. School Board Elections

The NSSBA chaired a committee of the joint education partners to develop and implement a communications plan for the 2008 school board elections. Representatives of school boards, teachers, administrators and Department of Education officials met throughout the year to develop strategies and tools to promote greater public awareness of the elections. Goals were twofold – to encourage more people to run for school board office, and to encourage more citizens to vote. The partner model, which is believed to be the first of its kind in Canada, was an effective way to pool resources and ideas. The school board elections committee has recommended that this model be followed in 2012.

#### 2. Joint Partners' Lobby Campaign

Since December 2008 the NSSBA has provided leadership in mobilizing the joint education partners to develop and implement a lobby campaign encouraging the government to continue its investment in public education. The association has also been vocal with regard to the timing of this year's budget. The campaign *Public Education: Our Best Investment!* garnered extensive coverage from the media and positive support from editorial boards. The campaign raised awareness of the issue to politicians and the public. All partners held numerous meetings with politicians, and strategic print and radio ads delivered key messages to the public. The partners were seeking a 4.5 per cent increase in funding for public education in order to maintain services to students. A rare joint news conference of the partners was held on January 15, with many reporters in attendance. It was effective to have all partners speaking with a united voice and a consistent message.

#### 3. Board Member/Staff Development

#### a) Conferences/Seminars

- The NSSBA, in partnership with the Department of Education, hosted an orientation seminar for new and returning school board members, November 27-28 in Dartmouth.
- NSSBA was part of the planning committee for the Atlantic Conference 2009, Where Have all the Students Gone?
   Implications for Governance, January 29-31 hosted by the Newfoundland and Labrador School Boards Association.
- The NSSBA worked closely with the Strait Regional School Board to prepare for the association's 55<sup>th</sup> annual general meeting and conference, May 14-16 at St. Francis Xavier University. The theme is *Celebrating Cultural Proficiency and Equity in Education*.

#### b) Communications Networking Group

The school board communications staff members meet several times throughout the year to discuss issues of provincial and local concern, share ideas and information, and receive updates on their national professional association, the Canadian Association of Communicators in Education (CACE). The NSSBA and the Department of Education host these meetings.

#### 4. Canadian School Boards Association

NSSBA has worked closely over the past year with our colleagues throughout the country through the Canadian School Boards Association (CSBA). Our president and executive director serve on CSBA's board of directors.

NSSBA is honoured to host colleagues from across the country at this year's annual CSBA Congress on Education. Congress 2009 will be held July 9 – 11 at the World Trade and Convention Centre and will focus on future trends in public education. *Class of 2020: Vision for the Future* will feature futurist Tod Maffin, aboriginal activist Candy Palmater, grocery guru Pete Luckett and Cape Breton educator Charles MacDonald, as well as a host of workshop presenters.

#### 5. Technology

The group e-mail list for school board members has become a very efficient method of communication with our members. Month In Review and Directors' Highlights are sent via e-mail. Fax is also used for those members who do not have access

to e-mail. The association website continues to be a key communications tool and the communications committee is responsible for regularly reviewing its efficiency and timeliness.

#### 6. Awards Programs

The NSSBA coordinates three award programs – the NSSBA School Board Member of the Year Award, the NSSBA Education Week Partner Award, and long service awards. For more information on these awards, please see the awards section in this annual report.

#### 7. Media Relations

The NSSBA issues news releases to the media through an arrangement with CNW Group. The association also subscribes to a media scanning service. News conferences are held as needed.

#### 8. Advertising

The association places ads in strategic publications – the Halifax Herald, the Cape Breton Post and Le Courrier de la Nouvelle Écosse.

#### 9. Promotions

The communications committee provides direction on the promotional items purchased for marketing and for presenter gifts.

#### 10. Hotel Liaison

The Holiday Inn Harbourview, Dartmouth, continues to be the NSSBA's preferred hotel for 2009.

### **Lead and Achieve Report**

#### **Major Initiatives 2008/2009**

#### 1. Education Funding Lobby Campaign

The main focus of the Lead & Achieve Committee for this past year was to ensure adequate funding for public education. Given that there was no increase in funding for the 2007/08 year, the committee was very concerned regarding the funding for 2008/09. This concern was heightened by the decline in the world financial markets and the fear that there would be no new dollars for education. Working with board chairs and superintendents, the committee was able to identify what the impact would be to the system if there were no funding increase.

In late 2008 the NSSBA provided leadership to an intensive lobby campaign involving the major education partners. The Nova Scotia Teachers Union, the Nova Scotia Federation of Home and School Associations, the Association of Nova Scotia Educational Administrators and the Nova Scotia School Boards Association shared resources to develop the campaign Public Education: Our Best Investment! The initiative utilized print and radio ads, a website, Facebook and meetings with MLAs. A rare joint news conference was held January 15 to deliver the message that public education needs an increase of at least 4.5 per cent to avoid drastic cuts to personnel and programs. This percentage in real dollars is between \$45 – 50 million. The presidents of the four partners also met with editorial boards of two of the major papers. Media coverage was extensive. Throughout the winter the partners continued to meet with politicians, other partners and their own members.

The organizations involved in the partnership were pleased to hear the recent funding announcement of \$44.8 million dollars for education. While it is far from perfect, it does provide boards with a comfort level that in these tough economic times they can maintain the status quo with little disruption to programs and services for students.

The partnership approach has been viewed as a success by all participants and all agree it should be used again in the future, when appropriate.

#### 2. Revised Briefing Deck

The Lead & Achieve Committee revised the Briefing Deck – a document for use with members, partners and politicians. The document outlines challenges of school boards, sets out the NSSBA's Six-Point Action Plan, discusses progress of school boards in curriculum areas, and indicates how additional dollars would be used. The Six-Point Action Plan is listed below.

#### 3. NSSBA Six-Point Action Plan

- 1. Align curriculum with skills and outcomes required for the next generation.
- 2. Continue to support students with diverse needs via customized programs.
- 3. Improve inter-agency and governmental collaboration with organizations that help students at risk.
- 4. Focus on schools as "Professional Learning Communities" where teachers and principals have the resources to share best practices.
- 5. Foster collaboration between the NSSBA, the Department of Education, teachers, parents, students and other partners dedicated to improving academic performance.
- 6. Accelerate the implementation of the capital school program.

NSSBA agreed to provide the Department of Education with bookkeeping services and process payments on their behalf for the project.

#### 6. Timeliness of Reports

Provided the board of directors with regular reports throughout the year in order to keep them up to date on the financial activities of the association.

#### 7. Sponsorship for Congress 2009

Raised over \$50,000 in Corporate Sponsorships for the Canadian School Boards Association National Conference being held at the World Trade and Convention Centre in July 2009.

#### 8. NSSBA Pension Trustees Committee

As a staff resource, attends meetings of the NSSBA Pension Trustees Committee and acts as a liaison between the committee and the consultants. Participated in six information sessions around the province to bring members of the pension plan up to date and give them an opportunity to ask questions.

To celebrate Education Week 2009, schools across Nova Scotia are "Bringing Arts to Life". Drawing attention to the value of the fine arts in a well-rounded academic program is the goal of this year's Education Week theme. The recipient of the NSSBA Education Week Partner Award is Faye Haley, chairperson of the Tri-County Regional School Board, who has been bringing arts to life both as an educator and as a school board member.

Faye's involvement in the arts began in secondary school when she participated in drama, debate, public speaking and piano. During her years at Acadia University, Faye was a member of the university's drama society, drama workshop, school newspaper and the Acadia Light Opera Society. She also took part in the Dominion Drama Festival.

While teaching, Faye spent more than 25 years as advisor to the school newspaper and the drama club. She assisted students with variety shows and local productions. Faye was a member of the provincial steering committee to develop drama courses for Nova Scotia schools, and taught the first drama course at Digby Regional High School. In class she encouraged students to convey their understanding of literary works by creating artistic pieces as an alternative to written submissions.

These days Faye continues to engage in a wide range of theatre activities. Her recent voluntary contributions to the arts include the following roles:

- member of the board of directors of the Digby and Area Theatre Society
- member of the Digby and Area Arts Council
- member of the organizing committee for the Maud Lewis Festival
- various functions with Basin Productions, a local theatre company
- volunteer with the Scallop Days Queen Pageant, including the talent competition

As a school board member, Faye was instrumental in forming the board library committee and has been a strong advocate for the value of arts in the Nova Scotia school system. She consistently reminds the board that the arts are not "frills", but are essential to the development of a well-rounded child.

An integral part of the NSSBA for over ten years, Faye has participated as a voting delegate at its AGMs, has presented workshops at NSSBA conferences and currently sits on the Lead & Achieve committee.

Faye continues to build a legacy of enthusiasm for the arts - an enthusiasm which has been inherited by her children and grandchildren who are heavily involved in theatre as well.

The Long Service Award is designed to recognize school board members who have served the board 10 or more years. The recipient must be a current board member and fit in one of the following four categories:


Level One: Three terms or ten years of service
